Full size pickup is considered 3 yards if full to water level \$150.00

Shingles – Maximum 3 yards/day \$85.00/yard

*Appliances must have EPA tag that Freon has been removed in order to dispose at the town facility.

ACCOUNTS THAT ARE TWO MONTHS PAST DUE WILL BE DENIED ACCESS TO THE TRANSFER STATION UNTIL ACCOUNT IS PAID IN FULL.
