LOCAL LAW NO. 2 OF THE YEAR 2017

Section 1. Local Law No. 1 of the Year 2008 is hereby amended to provide that the exemption authorized previously shall apply to qualifying owners of qualifying real property for as long as they remain qualifying owners, without regard to such ten (10) year limitation.

Section 2. The remainder of Local Law No. 1 of the Year
2008 remains the same, to wit:

EXEMPTION FOR COLD WAR VETERANS

1. Purpose

The purpose of this article is to adopt the Exemption for Cold War Veterans allowable pursuant to §458-b of the Real Property Tax Law.

2. Statutory authorization; exemption

Pursuant to the provisions of Subdivisions (2)(a) and (2)(b) of \$458-b of the Real Property Tax Law of the State of New York, the Cold War Veterans exemption from real property taxes allowable pursuant to \$458-b of the Real Property Tax Law is established as follows:

- A. Qualifying residential real property shall be exempt from taxation to the extent of 15% of the assessed value of such property: provided, however, that such exemption shall not exceed the lesser of \$12,000 or the product of \$12,000 multiplied by the latest state equalization rate for the Town of Washington.
- B. In addition to the exemptions provided by Subsection A of this section, where the Cold War veteran received a compensation rating from the United States Veterans Affairs or from the United States Department of Defense because of a service-connected disability, qualifying residential real property shall be exempt from taxation to the extent of the
