TOWN BOARD RESOLUTION NO. 003 OF 2025

A RESOLUTION AUTHORIZING THE SUPERVISOR TO ENTER INTO AN INTER-MUNICIPAL AGREEMENT WITH THE VILLAGE OF MILLBROOK TO ESTABLISH NEW YORK STATE ROUTE 44 AS THE DESIGNATED TRUCK ROUTE THROUGH THE TOWN AND VILLAGE

WHEREAS, the Town of Washington and the Village of Millbrook recognize the need to manage and regulate truck traffic in a manner that enhances public safety, protects infrastructure, and maintains quality of life for residents and businesses in both municipalities; and

WHEREAS, New York State Route 44 (NYS Route 44) traverses both the Town of Washington and the Village of Millbrook and is the most appropriate and capable roadway to serve as the designated truck route for through truck traffic; and

WHEREAS, the Town and Village have collaborated to develop an Inter-Municipal Agreement (IMA) to jointly designate NYS Route 44 as the official truck route within their respective jurisdictions and to implement appropriate signage and enforcement measures; and

WHEREAS, the proposed action constitutes a Type II action under the State Environmental Quality Review Act (SEQRA), specifically under 6 NYCRR §617.5(c)(20), as it involves the adoption of regulations and agreements involving routine or continuing agency administration and management, and thus does not require further environmental review; and

WHEREAS, the Town Board of the Town of Washington finds it in the best interest of the Town to enter into said Inter-Municipal Agreement with the Village of Millbrook;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Washington hereby classifies this action as a Type II action under SEQRA; and

BE IT FURTHER RESOLVED, that the Town Board hereby authorizes the Town Supervisor to execute the Inter-Municipal Agreement with the Village of Millbrook, in substantially the form presented to the Board, with such non-material modifications as may be approved by the Town Supervisor and Town Attorney; and


BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.
